8. BUSINESS ARISING FROM THE MINUTES

There was no business arising from the minutes.

9. REPORT OF THE PRESIDENT

The President provided on update on the University's response to the pandemic. In particular, he noted: a few of the adjustments undertaken and some accomplishments; priorities and challenges; ongoing conversations with the government; research on COVID-19 being done at Waterloo; how the University is supporting the external community.

In discussion: safety is top of mind in every activity and decision; the University's Emergency Control Group has been meeting more than once a day and over weekends; a question about the status of the library and subsequent feedback *via* DiVidi from Beth Namachchivaya that only digital resources are available at this time, and that the library will work with all instructors regarding resources now and for the spring term; budget implications and the effect on international student

enrollment are unknown but being actively monitored; plans regarding convocation; confirmation that IT security is a high priority; the fall term is being considered presently; a statement from Tolson on behalf of FAUW in support of the hard work of the whole community in the response to the pandemic; the University is not aware of any cases of COVID-19 on campus; considerations being taken by the Graduate Studies and Post-doctoral Affairs office with regard to graduate student progression and field work; the efforts being taken to enable research safely; ways the University is in touch with Public Health.

10. REPORTS FROM COMMITTEES AND COUNCILS

Finance Committee

Senate heard a motion to recommend that the Board of Governors approve the 2020/21 Operating Budget, as described in Attachment 1.

MacEachen and Tizhoosh.

The Provost presented the 2020/21 provisional operating budget. Speaking to his slides, Rush discussed: provisional projected revenue and expenses; the sources of the uncertainty; details regarding income and expenses. In discussion: adjustments will be made in light of real enrollments; salary expenses are predictable due to staff and faculty both being in the last year of multi-year agreements; a deficit of \$6.5M is anticipated at this time; schedules on the Finance website provide greater detail.
