#### **COURSE DESCRIPTION**

Haudenausaunee translates "people who build the long house" imparting the culture with a uniquely architectonic identity and duty making it particularly relevant to architects.

The course is directed at understanding the relationships of aboriginal culture and land to architectural expression, through the lens of Haudenausaunee [Iroquois] culture, now based in the Grand River watershed. Initiating with Haudenausaunee Creation narrative, the course of the development of the culture and its architecture is traced through a set of twelve periods culminating in its modern expression.

In the deepest sense, all true architecture is practiced as cultural "duty", but to do this one must be conscious of what actually comprises one's culture as an indigenous person, and out of respectfully acknowledging place as "settler" in adopted the homeland of the indigenous ancestors of the place. The course is designed to help one understand this identity, and to begin the process of assuming this deeper sense of place as a part of the process of "decolonization". The architectural implications are enormous. A recovered indigenous relationship to fabrication, measurement, and the materials and techtonics of the natural world will give expression and form in a new/old architecture.

## COURSE ASSESSMENT

In additions to the assignments and experiences of ARCH 285, the student will be required to keep a detailed reflective journal based on attendance at the lectures, experiences of the course, and complete readings of the course. This will be the central basis for final evaluation.
