Course Description and Objectives

This course is designed to help students build some basic skills for academic research and writing.

The course consists of handouts and tests on the subjects of: editing, citing, sourcing, reading, planning, research, and writing.

Course Structure

The course consists of two sections: handouts and assignments. To begin with, students are required to read all the handouts. Students then complete the following three assignments:

- 1. Edit a text
- 2. Add citations SEP
- 3. Write a précis

All course materials, including instructions and due dates, are available on the Course's Learn site.

Evaluation

This is a Credit/No Credit course. You will receive a credit if you complete all three assignments and submit them on time. You will receive no credit if you fail to complete all three assignments and submit them on time. The due dates for the assignments are listed below. Due dates can only be extended in cases of illness, incapacity, or special circumstances, with an accompanying, valid note.

The evaluations consist entirely of samples and feedback from the instructor, where necessary. There is no marking.
