# **Constitutional Amendments Discussion**

**Discussion:** The ASU would like to make some minor changes to the Arts Student Union's constitution with the intention of further clarifying the expectations of executive roles. The first and most fundamental amendment we wish to make is to change the name of the Vice-President Executive role to Vice-President Internal. In addition to this, we wish to add a crucial responsibility to the role in writing which would require this executive to hold termly meetings with all societies individually in collaboration with the VP Finance. The main purposes of these meetings would be to discuss termly budgets and game plans (in terms of events and proceedings of the society), as well as to promote better ties between departmental societies and the ASU executive team. This ASU executive team feels that this new formed tie would encourage collaboration as well as affirm the ASU's role as a helping hand to all societies in the faculty.

The other change which the executive team wishes to put forward is to add an amendment the role of the Vice-President Communications. The premise of this amendment is to constitutionally entrench the expectation that if in the event that a VP Communications lacks a background in design, they will acquire a commissioner who is capable of producing marketing materials for all of the ASU's events and endeavours.

Lastly we will also be correcting any grammatical anomalies and capitalization errors.

The executive team wishes to emphasize our desire to be transparent and opens up the floor to any questions or concerns regarding the proposed amendments. After any necessary discussion takes place the motion will be put forward for the approval of the finalized constitutional document which will be voted for or against at the final council meeting of the term.

# **Grant Proposals**

# Assyrian Chaldean Syriac Student Union's Event Grant Proposal

**Proposal**: The student union asks the ASU for money which will fund a banner for their club and food for their Easter Event (\$180 total). They emphasize that they are anew club which only receive the minimal termly funding of \$75 from FEDs which does not allow them to do as much as they would like to. The student union emphasizes their mission of educating UW students about their culture and creating an even more culturally acceptant culture on campus.

**Questions:** The Council asks the representative if they have spoken with other faculties' societies about funding, to which the representative responds that they have not done so yet.

# Global Business Brigades UW Scholarship Grant Proposal

**Proposal**: The Global Business Brigades are planning to send volunteers to Honduras this year and are holding the Mission Possible Event on March 24<sup>th</sup> to help fund the volunteer effort. They ask the Council for \$1720 which will be used to provide scholarships for two volunteers to go to Honduras. The representative emphasizes that this is a great way for students to learn about different cultures, and do positive things in the world. The ASU would receive platinum level sponsorship status, if they provided the scholarship grant and the representative approaches the ASU because volunteers have largely consisted of Arts students in the past. Lastly, the Global Business Brigades will provide Arts Students attending Mission Possible with a discounted \$15 entrance fee to attend the event. All profit from the event goes toward funding the local banks in the countries that they're volunteering in as well as the funding of volunteers going to Honduras this year.

**Questions:** The Council asks if the representative has only reached out to the ASU for funding. They responded that they have reached out to Math Endowment Fund and their scholarships are being restricted to math students. The council asks which proportions of the volunteers were in Arts last year. The representative explains that of 14 volunteers last term, 9 were in Arts.

**Discussion:** The Council acknowledges that a large grant is being requested and wishes to approve the proposal on the condition that the two scholarships are award to Arts students only.

# Accounting and Finance Student Association Grant Proposal

**Proposal:** The society requests funding for AFSA Goes for Gold. The society is hoping to use an ASU grant to subsidize the cost for SAF students to participate in these competitions. # **Economics Society Prof Mixer Grant Proposal**

**Proposal:** The society is planning a mixer for the 15<sup>th</sup> of February and is requesting for the ASU to fund the space rental cost (at the Graduate House) and snacks; most specifically they are asking for \$500. The society feels that this is a productive use of money as it is a comfortable environment for student-professor interaction. The cost of the room rental is \$60/hour and they are hoping to rent the space for four hours (\$240). The additional cost of food for the event is based on the attendance of 40 students last term.

**Questions:** How much of the society's allotment has been used for this event? Has the society reached out to their department for financial assistance (as departments often cover the costs for on-campus venues. The society expresses that they want a financial "cushion" for upcoming terms. The VP Finance expresses the Accountant, Gurpreet's sentiment that societies should not be saving their allotments and should be termly allotments as are paid for by students on campus that term. Allotments are meant to be spent on students who fund those allotments. The society expresses their desire to use their allotment for their mentorship program, rebooting their marketing team, etc. They express that they have been in contact with their department and the department is more inclined to provide their services by the means of professors and not so much in a financial sense.

**Discussion:** The Council agrees that the event is positive for students, but raises concern about the society not utilising their allotment. This of course raises a past concern of creating a precedent where the ASU pre-emptively provides funding for events which have yet to be planned. The Council feels that there is a lack of clarity in the budget breakdown of the proposal, excluding the cost which will be covered by the society. The Council desires more clarity of this kind in the future so that it is easier to track just how much the ASU is funding society events in proportion with the society.

- Prizes: \$25 gift card for each person in the winning team (\$100), 2 students win the scholarship (\$860 each x 2 = \$1720)

- Rest of the revenue will be given towards our trip fundraising goal

Ticket fee: \$15/person within Arts Faculty, \$20 for rest of the students in other faculties We are looking for sponsors to help us with our other costs such as Walmart or Sobey's for food, and Starbucks for our winners' gift cards, however we have not yet been able to establish a partnership.
