



## COMPASS Data Usage Application Process

For any researcher/team/student to gain access to the COMPASS data, the successful completion and approval of the COMPASS Data Usage Application is required.

1. Fill out the data usage request form and sign the data usage agreement. You are required to list all variables of interest through the *Data Request* tab in the COMPASS Codebook 2012-2023 (Excel file), and to submit this file with your data usage application for every data request. If you do not have access to the COMPASS Codebook 2012-2023, contact COMPASS Program Manager, Katie Burns ([ke3burns@uwaterloo.ca](mailto:ke3burns@uwaterloo.ca)).
2. Submit your completed application by email to COMPASS Program Manager, Katie Burns ([ke3burns@uwaterloo.ca](mailto:ke3burns@uwaterloo.ca)).
3. Your application will be reviewed for subject relevance, methodological quality, and potential overlap with existing projects. If this application is for a peer-reviewed manuscript, the application will then be circulated to all COMPASS grant co-investigators (listed on the application form) for approval. Co-investigators may also suggest modifications or request authorship (only if merited through meaningful contribution and subject matter expertise).
4. A member of the COMPASS team will contact you with the result of your request. Please allow up to two weeks for approvals.
5. If approved, the COMPASS Data Analyst will reach out to obtain any additional information required to fulfill your request and to coordinate secure file transfer. Please note that the full request process takes approximately one month, depending on the amount of follow-up required.

## COMPASS Data Usage Guidelines

Data from the COMPASS study is stored at the University of Waterloo on a secure server. The Principal Investigator of COMPASS (Dr. Scott Leatherdale) maintains ownership of all COMPASS data. Access to specified COMPASS data may be granted to all COMPASS project collaborators and/or their research teams or students as well as external researchers/teams or students. Special preference will be granted to graduate student and internal collaborator requests.

1. I/We agree that these data will only be used for the purpose as stated in our application. I/We will not use these data for any other reason without written permission from the principal investor of the COMPASS project.
2. I/We agree to acknowledge the COMPASS data in all publications, reports, presentations, abstracts etc. resulting from the analysis.
  - a. The Principal Investigator, Dr. Scott Leatherdale, is to be included in all publications resulting from COMPASS with the understanding that he will be an active contributor/collaborator.
  - b. Notification to Dr. Leatherdale is required at points of acceptance of papers and final publication, with copies provided.
  - c. For graduate students using COMPASS data, it is expected that Dr. Scott Leatherdale will be included as a committee member of your thesis/dissertation.
3. I/We agree to the timeline for use:
  - a. I/We agree to submit a progress report outlining current progress, and any requested revision of the completion date should we surpass the agreed upon timeline.
  - b. Graduate students using COMPASS data will have special time provisions based on thesis/dissertation completion.
4. I/We agree to store all data sets in a secure password protected location.
5. All external UW parties will obtain proof of ethics clearance for secondary data analysis from an approved institution, prior to using the COMPASS data.
6. I/We understand that all COMPASS data is confidential and that we will only be provided with de-identified data on individuals, schools, or organizations.
