Course description

The undergraduate calendar description for this course is:

Market Failures

This course explores the many ways in which the assumptions of the perfectly competitive model are violated in the real world, and the consequences of these market failures for consumers and firms. The course examines potential government intervention to "fix" the failures as well as the limits of government intervention. Topics include monopoly/monopsony, externalities, the tragedy of the commons, public goods, asymmetric information, and incomplete information.

Evaluation

The final grade will be based on five take-home assignments, two term tests and a final exam.

Assignments (10% of the final grade)

There will be 5 assignments, worth 2% each. The assignments and their due dates will be posted on the course web site, which is stated above. The assignments must be submitted in person in class on their due dates.

In-class tests (30% of the final grade)

There will be two in-class tests, each worth 15% of the final grade. The first test will be held Tuesday January 29th. The second test will be held Thursday March 7th.

Final Examination (60%)

The final examination will be on the entire term's work and will be scheduled by the Registrar.

There will be no make-up assignments or tests. If a student misses an assignment or a test, and the student can provide credible documentation for missing the assignment or the test, the weight on the assignment or test will be transferred to the final exam. The credible documentation must be signed and handed to the instructor in class.
