Course Information

Overview

The course is designed to introduce students of economics to the mathematical tools actively used in economic theory. Topics include an introduction to matrix algebra, differentiation, partial derivatives, and optimization techniques including constrained optimization. Throughout the course the use of these mathematical tools will be shown.

The textbook for the course is *Mathematics for the Economists* by Carl P. Simon & Lawrence Blume. A copy of the text will be placed on a three hour loan at the Dana Porter library.

Evaluation

Grade
