## **Brief Summary**

This course examines the scope and level of government involvement in economic activity. The main focus is on historical trends and recent developments in the extent and composition of government spending, taxation, and regulation in developed nations. A secondary focus is to introduce the current policy debates in these areas.

There is a voluminous amount of material to cover in this course. We will attempt to get as far through the topic list as our limited time will allow.

Prerequisite: ECON 101 or ECON 100/COMM 103; ECON 102

# **Course Goals and Learning Objectives**

At the end of the course, students should be able to

- apply elements of microeconomic theory to understand how consumers and producers make rational decisions;
- explain the fundamental features of public goods, externalities and information asymmetry;
- apply theoretical understanding to problems of social welfare maximization;
- apply theoretical understanding to a variety of policy issues;
- explain the need for government intervention under certain market conditions;
- use applied economic techniques to analyze conceptual problems in a social insurance context.

#### **Course Requirements and Assessment**

The two individual assignments in this course will collectively be worth **20%** of your final grade. The two midterms will be written in the class period on the dates specified below and the results will be worth **20%** of your final grade for each midterm. The final exam will constitute **40%** of your final grade and will be <u>comprehensive</u> (i.e. cover all course material from beginning to end).

The course grade will be based on the weighted sum of the two assignments, the two midterm exams, and the final examination which will be held during the Official Examination Schedule. The breakdown is as follows:

#### Notes

- The format for both the midterms and the final exam will be a potential mix of multiple-choice questions and written problems.
- The midterm tests will be written during the class time.
- The final exam period for the Fall Term 2019 is December 6 21 inclusive. Students are expected to be available during this time. Travel plans are not acceptable grounds for granting an alternative final examination time.

Missing a Midterm Due to Illness during the Term

## Missing the Final Exam Due to Illness

If you miss that lecture due to illness and therefore cannot submit your assignment, it will be accepted for grading if and only if accompanied by a relevant medical certificate.

No make-up tests will be provided for the midterm exams. Students who miss a midterm and do not have a relevant medical certificate will receive a mark of zero. Students with a valid medical certificate will have the weight of the relevant midterm added to their final exam.
