### **Meetings:**

This class meets on Tuesday and Thursday from 10:00-11:20 am in STC 20.

### Overview:

This course introduces students to the analysis of inter-temporal trade-offs in macroeconomics. Its main objective is to show how economists use economic theory to analyze the role of incentives and general equilibrium considerations in the macro-economy. The course is intended to lay the theoretical foundations that underpin the upper level courses in Macroeconomics (Econ 406, 407, 408, 409, and 496).

#### Textbook:

There is no required textbook for the class. The recommended textbook is: Williamson, S. (2013) Macroeconomics. I will place a copy of the book on course reserve at the library.

I will post additional readings on UWLearn as the semester progresses.

### **Evaluation:**

There will be two midterm exams, each worth 20% of the final grade. The midterms will take place in class on the following dates:

Midterm 1: Thursday, February, 13<sup>th</sup>, Midterm 2: Thursday, March 19<sup>th</sup>.

There will be a final exam, which will be worth 45% of the final grade. The final exam will take place during the final exam period at a time and place chosen by the Registrar's Office.

Finally, there will be a series of written assignments that will make up the remaining 15% of the course grade. These assignments are to be handed in during class time, and late assignments will not be accepted unless the student and instructor have made a prior agreement to allow a late submission. The assignments will be equally weighted. Students are expected to complete all assignments on their own.

# **Policy on Missed Assignments and Tests:**

No make-up tests will be provided. A student who does not have a relevant medical certificate will receive a mark of zero on a missed test and that student's final grade will be computed in accordance with the formula specified above. For students who do have a relevant medical certificate the weight from the missed midterm will be applied to the final exam.

A student may fail to submit *one* assignment without penalty. A student who misses more than one assignment will receive accommodation only for missed assignments for which the student is able to provide relevant medical documentation. The form of the accommodation is that the weight from the missed assignments will be shifted to the final exam.
