# Course Objectives and Expectations

The course offers some insights into the factors impacting long-run economic trends as well as short-run macroeconomic fluctuations around these trends, allowing the student to gain useful understanding of how aggregate variables such as national income, employment and inflation are determined. We will also discuss economic stabilization policies and basic macro topics in open economies. As deemed appropriate, concrete examples based on current events will be offered to illuminate class discussions.

You are expected to attend classes as well as read the suggested chapters (in brackets in the outline below), ideally before and after each class. I will initiate class discussions as needed, and give you opportunities to ask questions on any topic that might be unclear. Should you remain uncertain about a particular concept or idea, please see me during office hours.
