ECONOMICS 421 (WINTER 2021)

COURSE DESCRIPTION

Economics 421 is the first course in a three course sequence representing the core of econometric theory and methodology required of advanced undergraduate students in the economics department. The objective of this course is to familiarize students with econometric models and techniques that are widely used in modern empirical research. The overall grade will be based on several homework problem sets and a term project.

TEXT

The recommended textbook for this course is *Introduction to Econometrics* by James Stock and Mark Watson (updated version of the 3rd Edition, Pearson) and *Microeconometrics Methods and Applications* by Colin Cameron and Pravin Trivedi (Cambridge). We plan to cover the following topics and I will follow my lecture notes closely:

- I. Review of Linear Algebra, Differentiation and Probability (1.5 weeks)
- II. Asymptotic Theory (1.5 weeks)
- III. Classical Linear Regression Models and Ordinary Least Squares Estimation (2.5 weeks)
- IV. Instrumental Variables and Two Stage Least Squares (2 weeks)
- V. Nonlinear Least Squares and Method of Moments (1.5 weeks)
- VI. Maximum likelihood estimation (1 week)
- VII. Limit dependent variable models (2 weeks)

GRADING

The overall grade will be based on several homework problem sets (40%) and a term project (60%). Homework will be marked by completion.
