University of Waterloo Department of Economics Economics 600: Mathematics for Graduate Students in Economics Fall 2021

- **Course Objective:** This course is a review of the basic mathematical tools that incoming masters and doctoral students need for their core economics and econometrics courses.
- **Suggested Reading:** There is no recommended text, and the course will follow notes that are posted online. Online resources that cover similar material include:
 - Osborne, M., Mathematical methods for economic theory: a tutorial and
 - Hansen, B. Introduction to Econometrics, Vol. 1 (Chapter 1)
- **Schedule:** We will cover the following topics. The focus will be on the special tools each broad topic that are used most often in economic and econometric analysis.
 - 1. Mathematical Basics: Sets, functions, logic and methods of proof
 - 2. Linear algebra: Vector spaces, matrices and rules for their use
 - 3. Calculus: Differentiation rules, Taylor expansions, implicit differentiation, integration
 - 4. Convexity: Convex sets, convex functions and quasiconvex functions
 - 5. Optimization: Unconstrained and constrained optimization, convexity, the envelope theorem
 - 6. Probability theory: Random variables, basic probability, special distributions

The material will be delivered in video lectures posted each weekday from August 23 to September 3. They will be available on the course Learn website (at http://learn.uwaterloo.ca). Course notes and the course outline are available at https://arts.uwaterloo.ca/~tmparker/econ600.html. You should plan on spending at least four hours each day engaged with the material. There are many topics to review and not much time to do it.

- **Office Hours:** This course is designed so that it can be completed asynchronously you can complete the entire course without needing to meet for class at any specific time. However, in case you need to ask further questions about the material, there will be office hours at 9am EDT (UTC-4 hours) on the Tuesdays, Wednesdays and Thursdays of the two weeks of class, held electronically (meeting details will be provided on the Learn site at the beginning of the course). Send me an email if you need to talk but are unable to attend at those times.
- **Evaluation:** Your course mark will be calculated on the basis of six assignments. Four of the assignments will be posted every few weekdays on the course Learn site. Two comprehensive assignments covering all previous material will also be posted at the end of each of the two weeks. Assignments will be submitted electronically (and can be repeated) so you will have immediate feedback about your progress through the course.

Assignments will have *suggested* due dates, usually about two days after they are assigned, because the course topics build on each other from beginning to end. You are strongly encouraged to finish assignments by their suggested due dates. However, due to the challenges of attending courses electronically and completing assignments remotely, your final course mark will be computed based on your assignment marks as they stand by noon EDT on September 7, 2021.
