## **Course Objective:**

This course focuses on econometric methods used to analyze dynamic economic models. We will start with general tools from time-series econometrics that are used as building blocks in larger dynamic models. Then we will move on to multivariate methods that are more specialized for the analysis of macroeconomic data.

#### Textbook:

There is no required textbook for this course. I will be using material from several books and will post notes to the course website as we go along.

## **Topics:**

The exact timing will be determined as we go along, but here are the planned topics in the planned order. The depth of coverage for topics 4 and 8 will depend on the pace of the course and class interest.

- 1. Stationary stochastic processes
- 2. Dynamic models with covariates
- 3. Model selection, prediction and inference
- 4. Models of time-varying volatility (maybe)
- 5. Unit-root and cointegrated stochastic processes
- 6. Vector autoregressions
- 7. Methods for panel data
- 8. Bayesian methods for dynamic structural models (maybe)

#### **Evaluation:**

Your mark will be made up of the following parts, with relative weights in parentheses below. Homework may be completed in groups of up to three people. There will be approximately one homework assignment per two itemized sections listed above.
