a. Robin Mazumder, GSO GradVenture program

GradVenture is a "one-stop-shop" for resources specific to graduate students. It is currently running as a website to address key themes of Inquire, Connect and Strategize. GradVenture is tailored to and is exclusive to graduate students. The site provides links and a list of services/resources for graduate students. Grad Venutre does not create resources, drive exposure to all the campus resources.

GradVenture will launch event in January 2017 to create a buzz, student feedback and develop workshops.

Gradventure specialist (PhD students) from each faculty are hired to prepare agap analysis, and find a solution to fill identified needs. How can the GSA Help?

- i. Let Grad Venture know what students tell you about professional development and skills.
- ii. Help promote Grad Venture
- iii. Share experiences as graduate students:
 - 1. Focus groups
 - Contact GRAD venture Director Angela Rooke: a2rooke@uwaterloo.ca

-Grad Venutre received funding for this year to hire graduate students, (from each faculty) on a "half-time" of a full position. Grad Venture

would like to have these positions on-going.

-Grad Venture should have some measurable activity that can show the value of the service. Show that graduate student can gain skills for industry.

8. Presentations:

a. Equity Policy Ad-Hoc Drafting Committee, Norman Kearney

The GSA will establish an Equity Policy Ad-Hoc Drafting Committee that will be tasked with developing an internal Policy. After the Orlando shootings in Florida, the GSA had no policy commitment of equity and inclusion, and what we will promote in the broader community. This would be a governing document and hope to have it adopted by Council. The work of the committee is to review drafts.

The Ad-hoc Drafting committee will work to have a policy draft prepared for Council for April.

b. UW Policy 42– Sexual Violence, Robert Bruce, Jessica Brake

Ontario government mandates that universities implement a policy on sexual violence to be in place by January 2017.

The UW governors defeated the motion that was brought forward by the UW President. The launch of this policy is a bit behind schedule and there is a need to have something in place in January.

A Working group identified three main concerns:

- i. Scope of the policy: where does it apply, only under the auspices of the university. The policy does not protect students who are at an event during an off campus event (ie conference) that is not part of the UW event. i.e. having dinner after the conference.
- ii. Does not protect visitors/contractors that visit/work on campus, even though it is a G policy.
- iii. We asked that there is a multi-stakeholder oversight committee. UW feels that there would only be a risk if they were not addressing the issue.
- iv. Question:

Why is it reviewing a policy on the day that it is implemented? The intent is to address concerns that are raised. Terms of Reference are in question.

A Motion is to ask Council to empower GSA President with a formal position to draft a letter to formally put the GSA concerns to the President of the University.

Freure: Where does the GSA stand on the oversight committee? The oversight committee is different than the working group that the GSA VP sat on.

- -The GSA can still push for the oversight committee during the review process.
- -The new working group beginning in January will not be including this multistakeholder oversight committee.
- -There is hesitancy in the event that people in the case will be identifiable.

Amos: RE: gag orders? UW feels that a gag orders would happen as an agreement between the parties. The imbalance of power within the case could make this awkward.

Esmail: Can the university go forward and enact the policy as it is?

-There is a required Ontario law that this will be passed before January 1, 2017, but the review will be reopened immediately.

Zhu: If we enact the policy as it is and if a student body was to be made aware of these concerns? Could it be an influence?

CEC and Council are working toward presenting the student voice, this is important that GSA is asking for a specific and reasonable number of students to sit on the committee.

Is there anything that other student groups could do here?

Any student can write to the secretariat on any policy, and/or it can be funneled through the GSA, Some student associations (at other universities) have made a public statement on their websites.

Goyal: If it goes through on the January 1, the university operates on a set cycle of 5 year and 2 year review. This policy, as an exception, will be in review as of January 2017.

Council agenda packages should include pertinent documentation from Senate to inform discussion at council meetings.

1. OGSA: Update

On behalf of OGSA I have hired a Part-Time Executive Director. The initial priority of this new staff member is to help the organization provide deliverables for its member associations. The hope is to create an organization, wherein student representative provide policy directives and the organization develops policies that can then be lobbied on to government officials.

2. CASA Update:

Our CASA delegate has assisted in reviewing policies A31.3 and A31.4 to see if there were any opportunity to add a graduate perspective. These were policies regarding international student employment during their academic programs. Additionally, our delegate has been attending biweekly meetings with the graduate committee, communicating with the policy committee and the head of the "Student Employment White Paper" from the undergraduate perspective.

Finally, our delegate will be contributing to that from a graduate perspective or writing another white paper from the graduate student perspective in the winter.

3. Board of Governors – Policy 42

Policy 42 (Sexual Violence) is moving forward to the Board of Governors to be voted on. The GSA-UW and the Federation of Students have been consulted heavily throughout the development process, however, some concerns still exist and will be raised at the Board before the motion is adopted.

In addition to these two questions, we are also seeking feedback on the process we have planned for developing the policy.

Although this year's orientation was a success, it would be great to have more involvement from the faculties and departments. A. Ongoing Activities

1. Council Membership

I am pleased to report a new member of Council: Joyce Tin Wai joins us from the Master of Public Service program.

2. New Councillor Orientation

Two workshops are being held for new councillors, and returning councillors, board members, officers, and staff members are welcome (and encouraged) to attend as well.

The main workshop is being held on Wednesday, November 2 from 10am to 1pm (location TBA) and will include a variety of campus partners, e.g. the GSO, the SSO, the Library, etc. The second workshop, which is being held for those who are not available on the 2nd, will be held on Wednesday, November 9 from 6:30pm to 8pm (location TBA) and will not include the campus partners.

The orientation workshops will focus on: relevant campus services and the problems that service providers frequently solve for graduate students; relevant university policies; GSA policies and procedures, official positions, and services; and, challenges and opportunities for improving the social and academic experience of graduate life at UW in 2016/2017. For the

November 2 workshop, there will be a networking break in the morning and a lunch will be served for all participants at 1pm at the Graduate House.

This is the first time that the GSA is providing such a comprehensive orientation for new councillors. We hope that it will support both Council and individual councillors in being more effective advocates for graduate students at UW.

B. Planned Activities

1. Midyear Progress Review

The review has been scheduled for Monday, November 21, 2016. A debrief report will be made available shortly thereafter.

2. Student Association Orientation and Policy

I will be sending an invitation for a meeting in early December with the leadership of the faculty, department, and program level graduate student associations. The meeting will focus a draft policy on the relationship between the GSA-UW and the other campus graduate student associations. Issues covered in the policy will include association governance, registration with the GSA-UW, Council appointments, GSI funding, and fee collection and disbursement.

3. Equity Policy

I have drafted terms of reference for an Equity Policy Ad-Hoc Committee (see agenda package). Jessica, Indi, and I have developed a plan for engaging with campus stakeholders to develop principles for a GSA Equity Policy. The ad-hoc committee will focus on writing the text of the policy, Jessica will provide primary support for the background work, Indi and I will chair the drafting committee, and the three of us will coordinate with the campus partners.

C. Monitoring Activities

1. MDEI Funding

I have been in contact with graduate students in MDEI and I was surprised to learn that they had not yet heard about the remedy chosen by the University. I am investigating.

D. Completed Activities

1. First Round of GSI Funding Decisions Announced

Indi and I have reviewed and made decisions on the requests for Graduate Student Initiatives funding received in the first call for proposals. There were eight requests: four were approved, one was conditionally approved pending further documentation, two were declined, and one was sent to the Social Advisory Committee since it exceeds the \$500 executive officer approval limit. Full details on the funding requests and decisions will be presented at the January meeting of Council in the SAC report.

A. Ongoing Activities

1. 'Enhancing Graduate Student Experience' Survey

The SPC (Strategic Planning Committee), and Norman, Jessica, and I are reviewing the final elements of the survey before submitting it to IAP (Institutional Analysis and Planning) and the ORE (Office of Research Ethics) for revision and approval. Thank you to the members of the SPC for their generous time and input!

2. Social Advisory Committee (SAC)

The SAC will have its first meeting on November 3, 2016. This committee will oversee the social activities and events of the GSA, including funding allocated to departments (Graduate Student Initiative Fund). A. Ongoing Activities

1. Survey Instrument

The survey instrument was reviewed by Institutional Analysis and Planning (IAP). Overall, the provided us with a lot of feedback on the survey. Generally speaking, their feedback was the following:

- The **survey instrument is too long**, which may cause us to have a low response rate.
- Some of the questions in the survey instrument are unclear as they do not direct the respondents as to how they should answer the question (I.e. Please indicate your level of agreement with the following statements).
- There is also a lot of positive biases in the survey.
- Having the equity section in the survey means that our survey will be required to go through ethics for approval.
- The survey introduction is also a bit too long, and could be shortened.
- We need to develop both a **privacy policy** and **contest rules** and make them available on our website.
- We were informed that **there are five other surveys going out to graduate students** specifically this fall, which may also lower our response rate. It was recommended that we release the survey in the Winter term as there will be no other surveys going out to their knowledge.
- It was recommended that the Grad House survey not be a separate, but rather it should just come at the end of our survey, otherwise nobody will answer it.

We have incorporated this feedback into the survey instrument. We are now finalizing the survey instrument before sending it to IAP for a final review. After IAP reviews it one more time, we will be going through ethics for approval.

2. Outreach Strategy

Indi led the Strategic Planning Committee in a discussion at our last meeting to determine some of the ways that we can best reach our membership. Indi is going to be taking the lead on redrafting the outreach plan based on this discussion, as well as our new timeline.

3. Privacy Policy and Contest Rules

We are working on finalizing our privacy policy and contest rules, as IAP informed us that it was necessary to have both.

B. Planned Activities

1. Town Halls

After the results from the survey comes back in we are planning on holding town halls in each faculty so that we can further explore the needs of graduate students. This will also help to ensure that the data has been interpreted accurately and that we are not missing anything.

C. Monitoring Activities

1. Strategic Planning Process/Timeline

Based on the feedback that was received from IAP and all of the changes that needed to be made to the survey instrument the timeline for the survey and drafting the strategic plan has been adjusted to the following:

Survey Release Date: Monday January 9th, 2017

In between we will doing the outreach / survey promotions

Analyze survey data / prepare for the town halls

Council Membership Report

November 9, 2016

The GSA promotes decision-making at the closest feasible level to graduate students. Whenever possible, we defer to student associations at the faculty, department, or program level for guidance on GSA services, policy, and advocacy. Decisions are relayed to the GSA by way of appointed councillors.

To ensure that graduate students are legitimately represented, a new registration process has been implemented. The process requires associations to register with the GSA each term and whenever their executive or GSA representative changes.

By registering, a student association becomes entitled to

- Appoint a councillor (or multiple councillors, in the case of faculty level associations);
- Receive fees charged to members of the association, which are collected by the University and held in trust by the GSA;
- Apply for funding under the new Graduate Student Initiatives program; and,
- Request administrative support and other assistance from the GSA.

The data that the GSA-UW had on the status of faculty, department, and program level graduate student associations and the methods for collecting these data were found to be poor. This process is intended to improve data quality and collection methods in the interest of accountability. It is hoped that the process will also promote better transition planning.

The process is being tested in the Fall 2016 and Winter 2017 terms and a policy will be brought forward for consultation with associations, councillors, and other stakeholders prior to being implemented on a permanent basis.

For graduate students who are not represented by a faculty, department, or program level student association, councillors are elected. Elections are being held in October 2016.
