
## **Project Innovation: Building on Success**

Project teams are encouraged to review the virtual learning content created through the first round of VLS EOI funding (released in January 2021) and to utilize, reuse, adapt and otherwise use this content in submissions for this second round of VLS funding. Submissions are to avoid duplication of these projects.

## **Digital Content**

Development and adoption of a portfolio of high-quality online materials at Ontario postsecondary institutions in English and other languages (for example, French, Indigenous); high-quality virtual simulations and/or lab content to reduce the strain on campus space and infrastructure and enable more flexible delivery to attract new markets for online learning in Ontario complete with learner wrap around supports

#### Sample content

- ---> Creation of new online courses (\$75,000)
- ---> Creation of new virtual education resource (\$25,000)
- ---> Adaption of an existing open educational resource (OER) (\$15,000)
- Creation of a new simulation, serious game or XR (AR/VR) experience (\$75,000)
- Create learner wraparound supports for virtual learning success (\$25,000)

#### **Top-Up Funding (15k, select up to two)**

- ---> Micro-credential
- ---> Sector wide impact
- ---> Learner engagement
- ---> Employer partnership
- ---> Connectivity options
- ---> Translation

## **Digital Content - XR Projects**

Provide postsecondary institutions with resources to access Ontario-made educational technology to produce high quality virtual learning content using XR, and to conduct evaluation with learners and faculty.

- Projects can test technologies and provide support for wider market distribution while producing content for use in Ontario postsecondary institutions. Technologies should be at a sufficient stage (TRL 7 or greater) in order to pilot test or otherwise deploy in an Ontario institution.
- Funding of up to \$150,000 is available
  - ---> Prototype testing (TRL 7) (\$25,000 \$50,000)
  - → Technology demonstration (TRL 8) (\$50,000 \$100,000)
  - ---> Pilot and market planning (TRL 9): (\$100,000 \$150,000)
- Industry partners are required to provide a 1:1 match for grants, in cash or a combination of cash and in-kind contributions.
- Pilot testing or deployment should include appropriate evaluation so as to provide the company with pedagogical proof-points for developing markets for the company's technology.



## **Digital Capacity - Targeted Supports**

Support institutions with low capacity to produce high quality virtual learning through funding to hire additional staff on a project-based or full-time basis to support the development of virtual learning materials

#### Funding can support:

- Instructional Designers, multimedia developers, Project
   Managers
- AODA compliance and accessibility experts
- Virtual learning content translation and copy editing
- Learning technology support and advanced LMS experience
- Other supports directly contributing to the development or distribution of virtual learning materials
- Funding to hire co-op students, work study students or other student positions
- Other supports as needed: Other learning design and development resources not captured in the capacity areas above



## **Digital Capacity - CVLP Support**

Support institutions with low capacity to produce high quality virtual learning through vouchers for the Central Virtual Learning Platform (CVLP)

The Central Virtual Learning Platform (CVLP) provides member institutions with supplemental design and production capacity to produce high quality virtual learning content, by way of connecting members to services including:

- Instructional Designers, multimedia developers
- Media production
- AODA compliance and accessibility experts
- Virtual learning content translation and copy editing
- Learning technology support and advanced LMS experience
- Other supports directly contributing to the development or distribution of virtual learning materials

## **Digital Capacity - International Marketing**

Support for continued development of sector-wide international marketing initiatives that promote Ontario as a leader in high-quality online education.

A key objective is to promote equitable opportunities for <u>all</u> postsecondary institutions to realize international student recruitment to Ontario.

- Applicants will be expected to provide a clear summary of their international marketing strategy, including target markets, expected outcomes and detail their cross-sector collaboration plan.
- Marketing and recruitment initiatives should demonstrate how they will leverage recent investments in virtual learning content and digital delivery
- Funding of up to \$400,000 is available. Applicants can apply for all or a portion of this.
- All applications will be expected to provide a budget justification that explains how the marketing activities will benefit the overall sector.
