GA 191 : Martin, John Gartshore

John Gartshore Martin family fonds. - [188-?]-2004, predominant 1909-1958. - ca. 2.4 m of textual records and other material.

John Gartshore Martin, Col. DSO, MID, Q.C. (1921-2007), was an officer in World War II and later became a lawyer in Kitchener, Ontario. The youngest son of John Alexander and Jessie (Wilson) Martin, John studied at the University of Toronto and was employed at the Waterloo Manufacturing Co. Ltd. until he enlisted in the Canadian army in 1941. At that time, he was posted to the Highland Light Infantry regiment as a reinforcement officer with the rank of 2nd Lieutenant. Before enlisting, he was a member of the Scots Fusiliers of Canada and trained with them at Niagara, Brockville, and Camp Borden. He also worked on staff at a military school in Vernon, British Columbia before being posted overseas in September, 1943. In 1944 he was transferred to the Lincoln and Welland Regiment (infantry), which participated in the landing at Normandy and the Allied advance through Belgium, the Netherlands and into Germany. Martin was promoted to the rank of Major and was awarded several medals, including a Distinguished Service Order and mention in despatches. After returning to Kitchener in 1946, he married his fiancé Mary Ann Kabel (daughter of Mr. and Mrs. Art Kabel of Kitchener) and enrolled in law school at Osgoode Hall. Upon graduating in 1949, he practiced law in Kitchener and retired as a senior partner of the law firm Clement, Eastman, Dreger, Martin & Meunier. Martin was involved in community service at St. Andrew's Presbyterian Church and several organizations in the Kitchener-Waterloo area. He and Mary Ann had three children: Cathryn Jean, John Jamieson, and David Alexander.

John Alexander Martin, O.B.E. (1880-1959), son of Rev. William M. Martin and Christena Jamieson, was an industrialist from Waterloo, Ontario. John, known as Alec, received a BA from the University of Toronto in 1902, and worked for the Canada Cycle & Motor Co. and the Russell Motor Car Co. before becoming manager of the Tire Division at the Dominion Rubber Co. in Montreal in 1917. In 1919 he became general manager, and in 1928 he began as vice-president. During World War II, he served in Ottawa as Deputy Rubber Controller for Canada from 1941 to 1945, at which time he assumed the position of Rubber Controller until 1947; he was awarded the Order of the British Empire for his work in this capacity. Martin was involved in community service in several local organizations including St. Andrew's Presbyterian Church; he was also a founding member and president of the Ontario Society for Crippled Children. In 1912, Martin married Jessie Gartshore Wilson, and they had three children: Wilson Alexander, William Jamieson, and John Gartshore.

Jessie Gartshore (Wilson) Martin (1885-1968) was a homemaker in Waterloo, Ontario. In 1912, she married John Alexander Martin, and they lived for a time in Vancouver before moving to Toronto and then Waterloo. They had three children: Wilson Alexander, William Jamieson, and John Gartshore. Jessie was the daughter of Richard and Margaret Wilson. Richard Todd Wilson ([1839?]-1927) was a merchant and manufacturer from Dundas, Ontario. He married Margaret Gartshore (1844-[193-]), daughter of John Gartshore (a miller in Fergus, Ontario) and Margaret (Moir). Richard and Margaret Wilson moved to Toronto in 1914. They had six children: Richard Steel, Anna Jacqueline, Alexander Douglas, Marion Forrester (called Merne), Margaret Helen (More) (called Madge), and Jessie Gartshore.

Wilson Alexander Martin (1913-[19--]) was the oldest child of John Alexander and Jessie Martin. Wilson graduated from the University of Toronto in economics and then worked at the Waterloo Trust and Savings Company. In 1939, he entered active service at the rank of Sergeant and worked on the staff of the Royal Military College in Kingston, Ontario. He was eventually promoted to the rank of Major. In 1942, he married Dorothy Elaine Pequegnat and they had two daughters, Margaret Christine and Nan. After the war, he had a career in industrial engineering and then management at the Dominion Rubber Company in Kitchener and Montreal.

William Jamieson (Jamie) Martin (1917-1944) was the second son of John Alexander and Jessie Martin. He graduated from the University of Toronto in political science and economics in 1939 and in 1941 he enlisted in the army. He was appointed to the Canadian Armoured Corps and began training in Brockville as a Cadet. During the war he was part of the Elgin and then the 1st Hussars regiments and was promoted to the rank of Lieutenant. On June 11, 1944, his regiment was involved in a battle at Le Mesnil Patry, northwest of Caen, France, and Lt. Martin was killed in action. He is buried in the cemetery at Beny-sur-mer in France, and there is a memorial stone for him in the Grove Cemetery in Dundas, Ontario. He was engaged to Muriel Clift who worked as a military nurse in Europe during the war. (Source: content of the fonds, donor records.)

Contents: fonds consists of records created and accumulated by John Gartshore Martin and other members of his family, primarily his mother and father John Alexander and Jessie Martin. Records relate to the lives and activities of John Gartshore Martin and other family members, including the impact of World War II. Includes photographs, correspondence, clippings, war memorabilia, ephemera, certificates, a scrapbook, military decorations, and other material.

Series 1 : Correspondence

Correspondence. - 1941-1946, 1994-2004. - 6 cm.

Contents: series consists of 140 pieces of correspondence and a small amount of related ephemera and clippings. Includes mainly letters written to John Alexander and Jessie Martin from John Gartshore Martin during his service with the Canadian military during World War II, describing his daily activities, social outings, leaves, meetings with friends and relatives, and general news about the war. Series also contains several letters from Wilson Martin, Jamie Martin, Jamie's fiancée Muriel Clift, and several other correspondents. The correspondence is in the form of letters, many of which include the original envelopes and stamps; aerograms with original stamps; and telegrams. Series also includes a small amount of correspondence between John Gartshore Martin and an acquaintance from Holland (1994-2004). Some material is in Dutch.

- File 1 **Correspondence from Jamie Martin.** - 1941-1944.
Contents: file consists of correspondence from Jamie Martin. Includes six letters to his mother and father and one letter to his Aunt Anna. One letter includes the original envelope. Loose material.
- File 2 **Correspondence from John Gartshore Martin : [1941?]-1943.** - [1941?]-1943.
Contents: file consists of correspondence from John Gartshore Martin to his mother and father. Most correspondence was written between June and December, 1943, while John was at a transit camp in Windsor, Nova Scotia, waiting to be sent overseas. Also present is an earlier letter from John during his studies at the University of Toronto. File includes 3 telegrams and 15 letters, most of which include the original envelope and stamp. Loose material.
- File 3 **Correspondence from John Gartshore Martin : January - June, 1944.** - 1944.
Contents: file consists of correspondence from John Gartshore Martin to his mother and father, written between January and June, 1944, while he was stationed in England. Includes 2 telegrams and 30 letters, most of which are aerograms with original stamps. Loose material.
- File 4 **Correspondence from John Gartshore Martin : July - December, 1944.** - 1926, 1944.
Contents: file consists of correspondence from John Gartshore Martin to his mother and father, written between July and December, 1944, from England, Belgium, and Holland. Includes 47 letters, some of which are aerograms and some in envelopes, both with original stamps. Enclosed with one letter is a letter addressed to Jamie from his grandfather Richard Wilson written in 1926. Loose material.
- File 5 **Correspondence from John Gartshore Martin : 1945-1946.** - 1945-1946.
Contents: file consists of correspondence from John Gartshore Martin to his mother and father, written in 1945 and 1946. Includes 2 telegrams and 22 letters, some of which are aerograms and some in envelopes, both with original stamps. The letter dated August 30, 1945, includes a copy of a memorial service for John's regiment (Lincoln and Welland) held at Nijverdal, Holland. Loose material.
- File 6 **Correspondence from Wilson Martin.** - [1943?].
Contents: file consists of a letter from Wilson Martin to his mother. Loose material.

- File 7 **Letters from various correspondents.** - 1944-1945.
Contents: file consists of letters to John Alexander and Jessie Martin from various correspondents. Includes four letters from Jamie's fiancée Muriel Clift while serving as a military nurse in Europe; a letter from nephew Walter; a letter from Col. R.B. Martin, and a letter from Col. A. P. [surname illegible]. The latter two are regarding the death of Jamie. Some letters are aerograms and some are in envelopes, both with original stamps. Loose material.
- File 8 **Correspondence between Derk Rouwhorst and John Gartshore Martin.** - 1994-2004.
Contents: file consists of correspondence between Derk Rouwhorst of Delden (Netherlands) and John Gartshore Martin regarding the liberation of Delden (April 3, 1945) and of Holland, and the anniversaries of these events as celebrated in the Netherlands. Includes four letters (one with original envelope and stamp), press clippings (some photocopies), and a photocopied letter to John from the mayor of Delden. Some material is in Dutch.

Series 2 : War Memorabilia

- War memorabilia.** - 1939-[196-], 1980-1994, predominant 1939-1949. - 3 cm. - 209 photographs : b&w and col. ; 24 x 17 cm or smaller. - 3 contact prints : b&w ; 23 x 18 cm and 17 x 24 cm. - 3 maps : col. ; 66 x 99 cm or smaller. - 1 negative : b&w ; 9 x 6 cm.
Contents: series consists of material collected by John Gartshore Martin relating to his time of service with Canadian army in World War II, mainly with the Lincoln and Welland Regiment, 10th Infantry Brigade, 4th Canadian Armed Division. Includes certificates of qualification, service, and recognition; ephemera; correspondence; maps; and other memorabilia. Series also includes scrapbooks containing photographs, newspaper clippings, ephemera, and correspondence relating to John's experience in the war. Also present are certificates relating to Lt. William Jamieson (Jamie) Martin and Wilson Martin. The linear extent of the series does not include oversized materials. Series arranged alphabetically. Some material is in Dutch.
- File 9 OVR **Certificate : in memory of Lieutenant Wm. J. Martin.** - 1945.
Contents: file consists of a certificate in memory of Lieutenant William Jamieson Martin, presented to John and Jessie Martin by the mayor and council of the Town of Waterloo. Oversized material. Originally in a frame.
- File 10 OVR **Certificate : welcome home Major Martin, J.G.** - 1946.
Contents: file consists of a certificate presented to Major John Gartshore Martin by the mayor and council of the Town of Waterloo in recognition of his service in WWII. Oversized material.
- File 11 OVR **Formation signs.** - 1945.
Contents: file consists of two copies of a poster depicting formation signs of various Allied units (including the 4th Canadian Armed Division), dated May 8, 1945. Oversized material.
- File 12 **Liberation anniversary certificates.** - 1994. - 1 photograph : col. ; 19 x 24 cm.
Contents: file consists of material relating to the commemoration of the 50th anniversary of the liberation of Holland (Bergen op Zoom) and Belgium in WWII. Includes certificates, a photograph of John Gartshore Martin shaking hands with the [Prime Minister of Belgium?], and a photocopied 1945 press clipping. Some material is in Dutch.
- File 13 OVR **Map : 4th Canadian Armoured Division.** - [after 1945]. - 1 map : col. ; 59 x 75 cm (sight) in frame 77 x 94 cm.
Contents: file consists of a map showing the movements (with dates) of the 4th Canadian Armoured Division from the UK, the crossing to Normandy, and the advance into Holland and then across northern Germany. John Gartshore Martin's regiment (Lincoln and Welland) was part of this division. The border of the map includes the crests of all regiments in the division. Originally in frame. Oversized material.

- File 14 OVR **Map : central Europe, sheet M2 : Oldenburg.** - 1944. - 1 map : col. ; 64 x 88 cm.
Contents: file consists of a map of Central Europe, published by the War Office [Canadian or British?]. Scale is 1:100,000. Contains ms. notes and markings. Oversize material.
- File 15 OVR **Map : north west Europe, sheet 2A & 3A : Walcheren-Amsterdam.** - 1943. - 1 map : col. ; 66 x 99 cm.
Contents: file consists of a map of the Netherlands, published by the War Office [Canadian or British?]. Scale is 1:250,000. Oversize material.
- File 16 OVR **Officer appointment.** - 1941.
Contents: file consists of a linen-backed document appointing John Gartshore Martin as 2nd Lieutenant in the army of the Dominion of Canada by King George IV, by command of the Governor General of Canada. Oversized material.
- File 17 **Official service documents.** - 1939-1946.
Contents: file consists of material relating to John Gartshore Martin's military training and official term of service with the Canadian Army. Includes correspondence from the Department of National Defence, certificates of military qualification, a certificate of service, and diagrammatic plans of an attack by the Lincoln & Welland Regiment called "the final punch". File also includes a certificate of military qualification for John's brother Wilson Martin.
- File 18 **Passport.** - 1940. - 1 photograph : b&w ; 6 x 5 cm.
Contents: file consists of a passport for John Gartshore Martin for travel into the United States of America. Includes a photograph of Martin. Loose material.
- File 19 **Pocket portfolio.** - 1943-1945. - 4 photographs : b&w ; 13 x 9 cm or smaller.
Contents: file consists of material collected by John Gartshore Martin during his time in active service and kept on his person in a photograph case issued by the Canadian Active Service Force. Includes photographs of his mother, father, brothers, and fiancée Mary Ann Kabel; officer's ration cards; and clippings of wedding announcements, including one for his brother Wilson and his bride Doris. Includes one page of ms. notes containing addresses and records of the number of letters John wrote to his mother and father and to Mary Ann. Some material is fragile.
- File 20 **Roll of honour : First Hussars.** - 1945.
Contents: file consists of a roll of honor for members of the First Hussars killed in action between June 6, 1944 and May 6, 1945. Lieut. W.J. (Jamie) Martin is listed on the first page. Loose material.
- File 21 OVR **Scrapbook 1.** - 1942-1949. - 196 photographs : b&w ; 24 x 17 cm or smaller. - 3 contact prints : b&w ; 23 x 18 cm and 17 x 24 cm.
Contents: file consists of a scrapbook created by John Gartshore Martin about his experiences in WWII. Includes snapshots, newspaper clippings, ephemera, and correspondence. Snapshots were taken during John's training in Canada and his time in Europe, and show sporting events; fellow officers and soldiers; towns, buildings, and countryside in Normandy, Belgium and Holland; tanks and other equipment; a post-war ceremony; and other subjects. Scrapbook includes a telegram from John's parents informing him of his brother Jamie's death, ts. information relating to battles, a letter to Jessie Martin regarding John's DSO, and other items. Clippings relate to John's involvement in the war and his decoration with the DSO by the Governor General Viscount Alexander. The scrapbook pages are not in order and have been left as found. Some pages contain identification for the photographs. Oversized material. Pages and covers are separated; some pages are blank. Pages are fragile due to brittleness. Some material is in French.

File 22 OVR **Scrapbook 1 : loose material.** - 1944-[196-], 1980, 1984. - 7 photographs : b&w ; 18 x 24 cm or smaller. - 1 negative : b&w ; 9 x 6 cm.
Contents: file consists of material collected by John Gartshore Martin relating mainly to his experience in the war, including social and sporting events and regimental memorial services. Includes ephemera, newspaper clippings, photographs, a negative, a guide map of London, and a 1984 letter to John from a researcher regarding his scrapbook. Clippings relate to the war and John's involvement in particular, and include the October 27, 1945 issue of The Maple Leaf (newspaper for the Canadian Forces, northwest Europe edition); a clipping about a post-war business trip to Europe by John Alexander Martin is also present.

File 22b OVR **Scrapbook 2.** - 1944-1945.
Contents: file consists of a scrapbook created by an unknown party (probably a family member or close friend) containing clippings from the Kitchener-Waterloo Record relating to local men serving in the war. Clippings describe the postings, promotions, and activities of the soldiers and officers, honours received, and news about those injured, missing, or killed. Some clippings relate to John Gartshore Martin, Wilson Alexander Martin, and Muriel Clift (fiancee of William Jamieson Martin). Some clippings are loose between pages of the scrapbook. Material is oversized.

Series 3 : John Alexander and Jessie Martin Family

John Alexander and Jessie Martin family. - [19--], 1909-1962. - 5.5 cm. - 1 photographs : b&w ; 21 x 26 cm or smaller.
Contents: series consists of material relating to John Alexander and Jessie Martin as well as their descendants and ancestors. Includes ephemera, ms. notes, souvenirs, a ts. history and a ts. biography, and other material. Includes records relating to the wedding of John and Jessie, and the career, community service, and funeral of John. Most of the material was probably collected and kept by Jessie Martin.
The linear extent of the series does not include oversized materials.

File 23 **Ephemera.** - [19--], 1909-1919, [194-], 1944.
Contents: file consists of ephemera and other material probably collected and kept by Jessie Gartshore Martin. Includes an invitation and program for a banquet in honour of Rev. William M. Martin; a ts./ms. list of people who contacted John and Jessie Martin upon Jamie's death; a postcard depicting a tank in Caen, France; a clipping of a photograph of John Alexander Martin; and other material.

File 24 **Martin, Jessie : family notes.** - 1927-1962.
Contents: file consists of several leaves taken from a bible belonging to Jessie Gartshore Martin, containing ms. notes she recorded about her family and significant events in their lives. Includes notes about the activity of her sons (and other acquaintances) in the war, memorials for Jamie, the deaths of her parents, the marriage of her sons and the births of grandchildren, and her health, as well as notes from church sermons. Neither the notes or leaves are in chronological order.

File 25 OVR **Martin, John Alexander : citation for distinguished service.** - 1957.
Contents: file consists of a citation for distinguished service received by John Alexander Martin from the Ontario Society for Crippled Children.
Oversized material.

File 26 **Martin, John Alexander : in memoriam.** - 1959.
Contents: file consists of material relating to the funeral of John Alexander Martin, who died on June 7, 1959. Includes a memorial guest book containing details about the funeral service and a register of visitors, flowers, and gifts of remembrance. Includes a ts. poem, the message given at the funeral by Rev. F.G. Stewart, ts. lists of donations, and a clipping of the obituary (several copies).

- File 27 **Martin, John Alexander : personal.** - 1935-1954. - 1 photograph : b&w ; 21 x 26 cm.
Contents: file consists of material relating to John Alexander Martin. Includes a command from Buckingham Palace regarding a medal, a ts. biography, a letter from the president of the Rubber Association of Canada, R.C. Bukinshaw, regarding Martin's resignation from the association, and a photograph of Martin and Buckinshaw.

- File 28 **Monkland Mills : James Wilson and sons, Fergus, Ontario.** - [after 1933].
Contents: file consists of a ts. history of the Monkland Mills in Fergus, Ontario, owned by James Wilson and his sons for over 80 years. John Gartshore and Andrew Mitchell began milling in Fergus in 1835. John Gartshore and his wife Margaret (Moir) had six children; their daughter Jacqueline married James Wilson who established Monkland Mills, and another daughter Margaret married Richard Todd Wilson, who became John Gartshore Martin's grandparents.

- File 29 **Souvenirs.** - [19--], 1911, [196-?]. - 2 photographs : b&w ; 4 x 5 cm and 3 x 2 cm.
Contents: file consists of sundry items probably collected as souvenirs. Includes a photograph album with a leather cover (empty); blank postcards depicting Clachaig (Scotland), a Vancouver parade, and the University of Toronto; buisness cards for a hotel in California; autograph booklets; and a print of a boy and a police officer.

- File 30a **Wedding gift list.** - 1912.
Contents: file consists of booklet containing a ts. list of the gifts received by Jessie Gartshore and John Alexander Martin at their wedding on August 28, 1912. Booklet contains hand-drawn illustrations as well as two ms. poems, and is bound by a ribbon.

- File 30b **Martin, John Alexander : memorandum of trip to U.K. and the continet October 16th to November 10th, 1945.** - 1945.
Contents: file consists of a memorandum regarding a trip to the U.K., Holland, and France undertaken by John Alexander Martin and J.R. Nicholson to research rubber manufacturing. The memorandum gives a detailed list of each day's activities.
- File 30c **Martin, John Alexander : report of a visit by J.R. Nicholson and J.A. Martin to United Kingdom, Holland and France.** - 1945.
Contents: file consists of a report made by J.A. Martin regarding his and J. R. Nicholson's trip to the United Kingdom, Holland and France for the purpose of researching rubber.
Title continues ...with a view to making provisions for Canada's crude rubber requirements and getting as much information as possible regarding the rubber position generally -- October 16th to November 10th inclusive."
- File 30d **50th Year of Service to Ontario's Crippled Children.** - 1972.
Contents: file consists of a publication from Easter Seals celebrating 50 years of service, of which J.A. Martin was president. Page six shows a picture of J.A. Martin and other past-presidents.
- File 30e **125th Anniversary of Canadian Confederation medal.** - 1993. - 1 photograph : col. ; 10 x 15 cm.
Contents: file consists of a information related to John Gartshore Martin receiving a 125th Anniversary of Canadian Confederation medal.

Contents: file consists of a picture sheet showing memories from the 1955 District III Gyro convention, of which John Gartshore Martin was a member.

Contents: series consists of newspaper clippings relating to members of the Martin and Wilson families, the involvement of the Martin family and the Lincoln and Welland Regiment in World War II, and other subjects.
