Contents: fonds consists of materials created and accumulated by Alida Burrett. Primarily includes material relating to Burrett's work with women's rights issues including equal pay and with the K-W Status of Women Group, as well as her peace work.

File 1 **Affirmative action.** - [ca. 1983].

Contents: file consists of an information kit on affirmative action from Employment and Immigration Canada.

File 2 **Bill 3.** - 1979.

Contents: file consists of materials relating to a private member's bill sponsored by Ted Bounsall regarding an amendment to the Employment Standards Act for equal pay for equal work.

File 3 **Bill 59.** - 1979.

Contents: file consists of materials relating to Bill 59 An Act to reform the Law respecting Property Rights and Support Obligations between Married Persons and in other Family Relationships. Includes news clippings, ephemera and publications from the NDP, submissions regarding the bill, etc.

File 4 Canadian federal election. - 1980.

Contents: file consists of materials relating to the political party platforms for the 1980 federal election. Also includes notes by Burrett on topics of concern to her in the election. Most of the materials were created by the NDP.

File 5 Community contacts. - [ca. 1979].

Contents: file consists of materials from other community organizations that had connections with the KW Status of Women Group. Includes materials from the Family Planning Network, Canadian Committee on Learning Opportunities for Women Waterloo Region, Social Planning Council of Kitchener-Waterloo.

File 6 Community Resources for Women. - 1979.

Contents: file consists of materials relating to the group Community Resources for Women. Includes minutes, ephemera, and organizational structure information.

File 7 Equal pay for equal work : clippings. - 1980.

Contents: file consists of clippings relating to the equal pay for equal work act.

File 8 Equal pay for work of equal value. - 1978-1980.

Contents: file consists of materials relating to equal wages for women in Canada. Includes statistics for women in the workforce in Kitchener-Waterloo, materials from the KW Status of Women Group on their campaign for equal, face on women in the labour force, and a three year report on affirmative action from the Ontario Advisory Council on Equal Opportunity for Women.

File 9 **Essays.** - [197-].

Contents: file consists of two essays written by Alida Burrett while a student. The first is on Empress Eugenie, and the second on women's search for identity.

File 10 Feminist Part of Canada. - 1979.

Contents: file consists of materials relating to the initial development of the Feminist Party of Canada. Includes purpose documents, clippings, ephemera, etc.

File 11 Kitchener-Waterloo Status of Women Committee. - 1979-1980.

Contents: file consists of materials created by the Kitchener-Waterloo Status of Women Committee. Includes primarily correspondence relating to equal hiring practices.

File 12 **Liberal task force presentation.** - 1980.

Contents: file consists of a typescript of a presentation to the Liberal task force from the KW Status of Women Group.

File 13 National Action Committee on the Status of Women. - 1979-1984.

Contents: file consists of materials created by the National Action Committee on the Status of Women. Includes newsletters, reports, minutes, memos, etc.

File 14 NDP position papers. - [ca. 1979].

Contents: file consists of NDP position papers, primarily relating to women and labour.

File 15 Nuclear disarmament and peace. - 1982-1984.

Contents: file consists of materials relating to peace and disarmament. Includes clippings, petitions, newsletters, a manifesto, etc.

File 16 Ontario general election. - 1981.

Contents: file consists of materials accumulated by Alida Burrett relating to party platforms for the 1981 Ontario general election. The materials are primarily created by the NDP.

File 17 Ontario NDP women's committee. - 1979.

Contents: file consists of materials relating to the development of the Ontario NDP women's committee.

File 18 Videoaction. - [ca. 1979].

Contents: file consists of a Canada Works proposal for a project called "videoaction." The project was the create three videos in cooperation with the University of Waterloo on women's themes, including one on the archival women's studies holdings.
