# 3 General Orders

### 3.1 WUSA Memorandum of Understanding Update and Re-signing

The MEF-WUSA MoU is due for re-signing. As WUSA invoices MEF for the full amount approved for clubs up-front, there is the possibility of funding not being fully used. A possible solution of dealing with such remaining funds is as follows:

- 1. WUSA invoices MEF for funds through the normal processes.
- 2. MEF asks clubs to keep track of what has been reimbursed under MEF funding.
- 3. If there is remaining funding after the allotted expiry date, MEF will reach out to WUSA to reallocate these funds to the WUSA Food Support Network.

Notes from Meeting:

- It's up to WUSA to keep track of the expenses. They have the same method for money coming from all sources.

- The WUSA accountants have to keep track of finances for the clubs, still a big effort. If clubs come back, can they keep track of their own finances? It's an honor system.

- If WUSA is able to keep track of these things, why can't we just get the money back?

- Reduce back and forth, would look good on the fund to send to food support services. If we got the money back, we could determine ourselves where to allot the money. A lot of Food support service users are also not undergrads.

- Request a club room on MC third floor from MathSoc.
