# **Course Description**

The UN journey from managing inter-state wars to humanitarian atrocities is examined through analyses of the use of force, the gap between legality and legitimacy, the UN-US relations, the North-South divide, and the importance of the an international rule of law. The analysis proceeds from describing the UN system to looking at UN operations and activities, the importance of human security and human rights, the UN's tools and instruments, and the need for policy, institutional and operational reforms.

## Evaluation

Research Paper: 50%

The first requirement is for approval **in advance** of a formal research proposal. A paper submitted without such advance approval will not be marked and will be assigned a grade of zero for this component of the overall evaluation.

The **research proposal** should include the research question and a working bibliography. The length should be 500-1,000 words. It will be due in my departmental drop box before the beginning of class on 31 January.

The **research paper** should be between 7,000-10,000 words *including* all notes and references. The final date of submission for the research paper is beginning of class on 27 March. Requests for extensions are unlikely to be entertained.

#### **Class Participation: 20%**

Students are expected and required to participate actively in seminar discussions.

### Critical Summary: 15%

For one week, students will write a summary and critique of the readings. They should identify the core theme(s) and resulting questions, outline the arguments and assess their strengths and weaknesses. The length should be between 1,000-1,500 words (no exception). The summary should be distributed by email to all class members by 5.00 pm the day before the class meets as a word or pdf file. The critique must be presented in class. Dates will be chosen/assigned on the first day of class. Late assignments will not be accepted. However, those with genuine reasons for not being able to meet their deadline may arrange **in advance** to switch with another student and I must receive the consent of both parties in writing.

## Class Presentation: 15%

Students will present a draft of their final paper to their peers and also act as a discussant for another student's research paper.
