Course Objectives

This course will introduce you to the major theories and practices in the field of Organizational Behaviour. The primary emphasis in this course is on the psychological processes that influence the workplace environment, the nature of work, and the behaviour of workers.

Examinations

Term Paper

The Assignment: Write a 10-12 page paper (text) expanding on a topic that was either discussed in the book/class or has been approved by the instructor. Your paper should include two parts. In the first part you should review findings of past research—a minimum of six academic journal articles—potentially including the following sections: a) definition, b) antecedents, c) consequences, and d) moderators. In the second portion of the paper provide your own personal opinions regarding the topic area. The second portion should be at least one quarter of the paper and no more than one half of the paper. *You may write this paper in pairs.*

Format rules (failure to follow these guidelines will adversely affect your grade):

1. Papers must be typed/machine printed (Do not hand in a paper that has been hand written!!).
2. The body of the paper MUST be **double spaced** with **1" margins** all around.
3. Your text must be in **12 point font**.
4. Please do not use covers. Use a single staple in the upper left hand corner.
5. Your paper must be spell checked and demonstrate the appropriate use of grammar.

Due date and late submissions: The paper is due at the start of class on November 21. Late papers will be docked two letter grades for every class that the paper is late.
