### Description

This course examines the major areas of Human Resources Administration including recruiting, salary administration, labour relations, benefits administration, employee relations, labour law, and organizational behaviour. We will review the role of Human Resources Administration in organizations and the manner in which Human Resources executives contribute to the well-being of a total enterprise.

You will use the textbook as your main resource in this course. Course modules follow the text closely and some modules have audio or video components as a companion to the text. Further, there are animations that clarify complex concepts, links to real-life cases and news items, and TED Talks to emphasize critical points and show application. Be sure to keep an eye on the News section, which I will update with new and current relevant cases, legal decisions, and new ideas.

Keep in mind that all content is testable on both the midterm and final examination. You will be able to get clarification on concepts by answering the survey questions provided at the end of some modules.
