- **6. CHAIR'S REMARKS** Brian Hendley
 - a) Board members Hanqing Wu and Peter Roe are completing their term on the Board as of December 31, 2020. Along with a fond farewell, Brian Hendley expressed appreciation for their service and dedication to the Board. A brief bio of each member was shared. Faculty Appointee Rob Case was thanked for his valued contributions to the Board as his term also ends December 31, 2020.

Finance- Q2 and Cash Flow- Mike Reed

October results look favourable as the month ended on target thanks in part to effective cost cutting measures. A cheque for \$207,000 has been received from the CEWS program and \$831,000 of the tuition revenue holdback was finally released. Revenue is behind by \$3.4M. Year to date and we are \$65,000 worse than budget. The cash flow is \$1M better than the last review due to the first CEWS payment being received plus an additional \$300,000 that was received but had not been reported. The resulting cash flow balance was \$4.7M. Approximately \$1.2M was used throughout the year. The \$2.5M line of credit has not been accessed.

The President expressed appreciation to the Finance team of Mike, Brenda and Jill for keeping on top of the financial situation. With continued cost saving measures we should be able to keep our heads above water. At the Staff and Faculty Town Hall tomorrow, employees will be reassured that Renison is not going bankrupt however some permanent staff layoffs will be necessary in the new year.

Renison has received approval from the government to accept International students. It is hoped that a number will be able to come in May or June. Planning is underway for a \$20M budget which includes \$14.4M revenue budgeted for degree, \$3.5M for CAPE and \$1.5M for residence (approximately 40% of the usual revenue in this area). In comparison, last year's total budget was \$24M. HR will plan carefully to support work where there is a revenue stream. Staff subject to layoffs will be handled with dignity and respect. Anyone currently on layoff will stay on the Infectious Disease Emergency Leave to January 2, 2021. After that date, there are 26 weeks to maintain benefits and determine any necessary layoffs. We know we will not have enough work for full employment for the beginning of the next budget year.

Student registration is healthy, and the Faculty of Arts revenue was better than expected. The tuition freeze by the government will continue for another 2 years. Many contributions to the Renison Recovery Fund have been received. The Cherry donation of \$325,000 for a student bursary has been received. A bursary from Walter Fedy is being finalized and will benefit marginalized students; the recent Lang donation will support 2 BIPOC students. The Truth and Reconciliation Committee has worked on a scholarship for BIPOC students. Donations have been coming in for the Staff Emergency Fund supporting staff with urgent need. The Annual Christmas Appeal will invite all to support Renison for our students and our wellbeing.
