

Personal POAs are not acceptable for these purposes.

# PROFILE OF KATHERINE LA HAY

— by Neal Moogk-Soulis, a writer and historian in Waterloo. When he marries University of Waterloo staff member Melissa Keith this June, the Soulis name will be added to the University of Waterloo payroll for a third generation.

"I baked cookies. Do you drink coffee?" So begins my visit with Katherine La Hay, the recently retired Senior Instructor for the Earth Sciences department. I mention that I prefer tea, and soon we are sitting at her kitchen table, but not without first stopping by the fridge to admire a fantastic action shot from the hockey rink. The fridge, like any grandmother's fridge, is covered with colourful art from grandchildren and pictures of the artists. The hockey rink action shot is of her grandson cheering his heart out.

Unfortunately, there are not action shots of Katherine in net. "The day that the photographer was there, there were not many pucks shot at me, most of the action was at the other end of the rink."

Katherine was born in Winnipeg but grew up in Sudbury where her father as an assayer for Inco. An assayer tests the mineral ore from the mine during the refining process to determine the composition of the various minerals. Her father had also been a surveyor for Inco so he was familiar with the outdoors. "We camped, fished, skied and explored. My dad even built a little playhouse for us on the edge of our property."

"I remember my father would come home some nights and ask my mother if she wanted partridge for dinner. If she said yes, we'd head out into the countryside and my Dad would get the partridge when they were in season."

While the La Hays lived in Sudbury, they made frequent road trips to Winnipeg where the rest of the family lived. This was in the era when the Trans-Canada Highway was in its infancy and it hadn't yet stretched all the way across Canada. "There were two routes that we could take, either through Michigan or through Timmins. Both routes were gravel. We camped and we fished along the way."

"It was beautiful too. All of the rock cuts were fresh along the north shore of Lake Superior. They were brilliant with amethyst."



Another feature was roadside rock shops where the discerning traveler could purchase rock samples that had been brought in from the nearby wilderness. One in particular, Witzel's, sold rocks and oil paintings. The La Hays became friends with the Witzels. Over the years, a visit to the Witzels became a social event. It was another shop that entered into her family. "One of those rock shops was run by a man named Hank. One day, my parents were visiting the shop and Hank said that he was thinking of retiring. My father said that he was thinking of buying. Well, a couple

of weeks later, we were at home and truck pulled up. There was Hank with everything that became Cambrian Gemcraft."

Katherine's parents continued to run Cambrian Gemcraft, first in the summers out of an ex-Hudson's Bay Company trading post in Naughton, southwest of Sudbury, and later as a mail order business. "My father collected many of the rocks himself with another fellow, but he would also buy rocks." Later, Katherine took over the business. "When we took things over, most of the records were vague. In time, we discovered that we were dealing with the same companies that my parents were purchasing from."

In high school, Katherine was an active Track and Field athlete until a back injury sidelined her competitive career. "I became a student coach. In those days, the Legion ran coaching clinics in Guelph and I went there for two summers. While I was there, I met John Powell who was an amazing man."

John Powell established the Department of Physical Education at the University of Guelph. Since Katherine was the first woman accepted into the program, she was featured in the promotional literature next to Jeff Kerr, the first man to be accepted in to the program. Kinesiology was not for her so after failing a term, she switched majors to a Science degree. She married and then started her Science degree. She was determined to catch up to the rest of her class, but ended up burning herself out instead. "After I failed the second time, they

made me wait a full year before coming back. It's not a story that I tell often, but I always used it if a student came to me in despair because they were going to fail a course. I could tell them that failure was not the end."

At the end of her student career, Katherine received first a Bachelor's degree and later a Master's degree. Her two children, Paul and Karen, had been born. "I'd considered teacher's college, but by that point I had had enough of sitting in a classroom. I also didn't want to be away at school while my family was so young."

After graduation, Katherine did contract work for Agriculture Canada. About this time she also met Owen White, who was an engineering professor at the University of Waterloo. Katherine inquired about any openings and was told that nothing was available. "Shortly after that, I got a phone call that asked me if I would like to teach geology labs to engineers. I talked it over with my husband Peter and we decided that I should take the job."

Katherine started at UWaterloo in 1977. Since she hadn't taken the course, she also sat in on the lectures. "By then Owen had started to work for the Ontario Geological Survey, but he would come back to teach his lectures. Owen had an inspiring rapport with his students. Since I sat in on the course, I knew what the students should know in the lab because I could say, 'you learned that in last week's lecture.' That comment kept them on their toes."

Field trips were another feature of Katherine's work. A favourite trip was to take second year students to Bancroft in late September or early October. "There were wonderful displays of colour that just took your breath away. Some years, we had a crop of foreign students who were not familiar with the countryside. Those fall colours impressed them."

There were some misadventures, night time card parties and lots of joking too. "I remember there was one dinner where we were all together in the hotel dining room. At the end of the meal, the waiter came over with the bill. Peter Fransom went through the bill and began asking, 'Who had the trout?', and none of us had, 'Who had the lobster?' I looked over and the wait staff was watching us because the grad students had put them up to it. All of them were pleased with the prank."

One of Katherine's career highlights came near the end of her career when she taught two weeks of labs to students at the University's Dubai campus. "The first year, I had to buy, ship and assemble the whole lab. I would arrive, recover from my jet lag, set up the lab, teach, and then fly back. When I got back, people would ask me, 'how was your vacation?""

For a geologist, the Dubai campus was a beautiful place and sometimes served as an outdoor classroom. "We could walk around the campus and identify rocks in the paving stones, on the walls and even some of the staircases. Where could you do that on the Waterloo campus?"

Ice sports, and particularly hockey, have been a more or less constant part of Katherine's life. She grew up playing shinny on the creek in front of her house in Sudbury and later played with the women's hockey team at the University of Guelph. This team dominated the Ontario Women's University circuit in the late 1960s and early 1970s. After university, she played in provincial women's leagues. She became a goalie when her team's goalie left the team. Too much winter driving inspired her to switch to become a ringette goalie when she turned 40.

The pull of the puck couldn't be ignored for long, and Katherine returned to hockey about 12 years ago. By this time she had divorced, moved to Waterloo, and

remarried. The Kitchener-Waterloo Women's Recreational Hockey League has 14 teams this year with the team's roster changing every year. "We have games on Saturday and Monday nights. Sundays, we play pick-up games. It's a fun time. No one is out to hurt anyone or to get hurt." The current league has players aged 19 to 67, four of whom are over the age of 60.

It was by way of hockey that Katherine got to fulfill a geologist's dream: to stand on rocks that were younger than she was. In October 2014, she was part of two Canadian teams that took part in an Icelandic tournament. The competition was intense and she was elected her team's MVP. She left behind four goalie sticks and traded her jersey for an Icelandic one. "I intend to play hockey as long as I can carry my

equipment. It's a great stress reliever. If I begin a game stressed out, by the end the stress is all gone."

When she isn't playing hockey, Katherine enjoys camping and biking trips. She met her wife, Faye, at the Valens Conservation Area, east of Cambridge. "I was biking back from Niagara Falls and racing a thunderstorm. I knew that I wasn't going to make it home in time, so I arrived at Valens and said that I needed a campsite quickly. It turned out that it was Faye's favourite spot so she had to settle for her second favourite spot when she arrived later that day." Katherine and Faye were married at Valens two years later and have now been married seven and a half years. They each have two children from their previous marriages as well as eight grandchildren.

# KEYSTONE CAMPAIGN STUDENT PROFILE: JESSIE ASHBOURNE

A desire to make a difference came at an early age for Jessie Ashbourne. When Jessie, a 2nd year masters student in AHS, was young, her grandmother was diagnosed with Alzheimer's disease. This ignited her desire to be part of the change needed in caring for our increasing aging population, especially those with dementia.

After finishing her degree in the interdisciplinary Arts & Science program at McMaster University, Jessie met with UWaterloo faculty member Dr. Paul Stolee,

Associate Professor, School of Public Health and Health Systems (SPHHS), and his supportive team at the Geriatric Health Systems Research Group. She was so impressed with this program that she decided to attend the University of Waterloo.

Under Dr. Stolee's mentorship, Jessie is focusing her research on transitional care for persons with dementia and their caregivers. As part of this research, she interviews older adults with dementia and their family members who have experienced transitions in the health care system including those between community, acute or long-term care settings. The exciting part about this project, she explains, is that the results will become part of an initiative to develop dementia strategies for the Waterloo Wellington and South West Local Health Integration Network (LHIN) regions. It is her hope that this work will help make dementia a local priority and provide impetus for further dementia strategy development at a provincial level.

In recognition of her academic excellence and in support of her research endeavors, Jessie was awarded the Waterloo Retirees Scholarship, which is awarded annually and supported by the generosity of Waterloo's own retirees, part of the Keystone family. This extra funding has allowed Jessie to devote more time to her school work and extracurricular activities on campus. Playing intramural sports, singing in the University choir,



participating in the *Stand Up to Stigma* team, and holding the role of Vice-President Internal/External for the SPHHS Graduate Students' Association are some of the ways Jessie is involved in the campus community outside of her studies.

Jessie's future looks bright. She is looking forward to graduating in August and has applied to medical school with the hope that she may continue to apply her passion for the

health and wellbeing of older adults in the capacity of Geriatrician or Family Physician.

When Jessie is not on campus she loves spending time with her friends and the challenge of rock climbing.

Enjoy your climb to the top Jessie!







# PENSION AND BENEFIT UPDATE

A Cost of Living Adjustment (COLA) is applied to University of Waterloo pensions each year. Effective May 1, 2015, the COLA is 1.91%. If you retired on or after June 1, 2014, your COLA will be prorated based on the number of months you received pension since May 1, 2014. If you retired in 2015 and your pension was restricted by the 2015 Income Tax Act limit, your first COLA will be applied to your pension effective May 1, 2016. Please contact pensions@uwaterloo.ca if you have any questions.

Throughout his career, Paul Mitchell has shown leadership in both local and broader communities, roles which currently include directorships of Air Canada, Equitable Life, and the Council On Drug Abuse, which he chairs; and board membership of the KW Community Foundation, the Koffler Institute of Pharmacy Management, and several pharmaceutical organizations.

The University of Waterloo has been a principal beneficiary of his leadership talents, which he has shared generously, graciously and with good humour. It is fitting that he should be the recipient of the highest expression of our gratitude."
