Master of Environment and Business Financial Need Award Application

DESCRIPTION:

Master of Environment and Business (MEB) financial need awards support students who: 1) have demonstrated financial need; 2) diversify the sector involvement in a specific cohort; and 3) are enrolled in the Master of Environment and Business program in the School of Environment, Enterprise and Development (SEED), in the Faculty of Environment at the University of Waterloo.

• Financial need awards are tuition subsidies for students who are not receiving full tuition funding from their employer or another source. The awards are based on individual/household income and are available every year to eligible students registered in the MEB program. Students may apply each year they are enrolled if their individual income is less than \$50,000/year (in CAD dollars, and before taxes), or in the case of married students, their household income is less than \$100,000/year (in CAD dollars, and before taxes).

VALUE:

Financial need awards will be valued at \$500 per course x number of courses/year. Awards will be granted on an annual basis, with an opportunity to apply for renewal for each year you are in the program. Students must be registered in the program when the award is paid out. Students are not eligible for awards for terms in which they are inactive.

ELIGIBILITY:

The MEB desires to have a balance of participants from different sectors, including big companies, small & medium sized enterprises (SMEs), government, non-governmental organizations (NGOs), and self-employed. The MEB education will be enhanced by this experiential and scholarly diversity. Students are eligible to be considered for this award if:

- 1) Their personal income is less than \$50,000/year (in CAD dollars, and before taxes) OR
- 2) In the case of a married student, their personal income combined with their spouse's income is less than \$100,000/year (in CAD dollars, and before taxes).

Selection will be based on:

- 1) Financial need
- 2) Diversity of sector involvement in a specific cohort

Note: While the intention of the award is to provide a subsidy for tuition for each of the Spring, Fall, and Winter terms, the first allotment will not be credited to your account until after you have paid your Spring tuition. Spring term awards will be applied to your student account and will then be refunded to you via cheque. Fall and Winter term awards will be applied to your student account and will offset your tuition fees for the term.
