Course Description and Learning Outcomes

Course Description

This course reviews the history of global environmentalism, societal expectations and business responses, and the emergence of corporate social and environmental responsibility. It systematically presents environmental (climate change, air pollution, water quality and quantity, biodiversity, etc.), and social (human rights, health, poverty, ethics, fair trade, etc.) issues, their science, status and priority; technological, regulatory and policy responses; and implications for business. This course introduces concepts for business sustainability, including systems thinking, complexity and resilience, corporate responsibility, materials and energy flows and transformations, economic and market mechanisms, and relates these to business operations, marketing and strategic management.

This course is a foundational course and is normally offered directly after ENBUS 601. It ensures everyone in the class has a moderate knowledge of sustainability. For some of you, you will know aspects of this content already, so you will have the opportunity to refresh, share, apply and further your thinking; for others of you, much of this will be new.

Learning Outcomes

By the successful end of this course you should be able to:

- Identify and define sustainability terminology and related perspectives.
- Know basic history of corporate sustainability and key regulations, codes, frameworks and organizations.
- Understand and explain core sustainability concepts and issues.
- Determine key interactions between an organization and the environment, society, and the economy.
- Analyze application of course teachings to the organization or sector in which you work.
- Demonstrate timely and effective participation in virtual teamwork, peer-learning and online activities.

Paraphrasing and Quotes

There are many types of essays, but a good essay generally has some academic support through the use of research. It is quite acceptable to paraphrase scholars' work and in some cases to quote that work, but regardless of how you use that work, it all must be properly cited. If you do not cite someone else's work you are plagiarising.

Citation Style Guides

There are many different citation styles, but they share common information. Citations are intended to guide the writer/reader to the sources that were used and to give credit to the author of the quote or ideas summarized in an assignment or paper.

The MEB program uses the latest version of APA Formatting.

Online Citation Tools

Many online tools help you to capture the information you need in order to cite your sources properly. The library has the licensing rights to <u>RefWorks®</u> along with a tutorial. Other tools found online include: <u>Citation Machine</u>, <u>Zotero</u> from Firefox or <u>Easy Bib</u>.

Using pictures, tables, graphs etc.


Graphics, figures, tables and graphs that have not been created by you all need to be cited with a page number. If you have modified something created by someone else, you also need to cite it. Contrary to popular belief, just because it is posted on the Internet it is not "free". If you use the material, even with proper citation, you might be committing a copyright infringement.



In 1996, Dr. Clarke founded the Sierra Youth Coalition, and is proud of having launched their sustainable campus program which created change on more than 80 university campuses.
