ADDRESS TO COVID-19

Keeping government recommendations in mind, the ACHIEVE team will be taking necessary precautions to ensure the safety of all participants. To guarantee a successful and safe conference, we are establishing several recommendations and guidelines for all participants.

Recommendations for the ACHIEVE 2023 Conference include:

- Masks are recommended to be worn during the conference, with the exception of mealtimes.
- Networking sessions with representatives will occur in smaller groups to maintain social distancing.

- Teams must consist of 3-4 members, specifically 3rd or 4th year accounting/business students.

- · Any teams that cancel or fail to show up for the conference will not be issued a refund. Refunds will only be distributed in the event that ACHIEVE 2023 is cancelled or moved online (in which case, a partial refund would be issued).



CASE CUT:

On Day 2 of ACHIEVE, teams will be cutting the case. Everything needed to complete the case will be provided such as an uninterrupted space as well as any necessary tools and materials. Each team will have 90 minutes to analyze and solve the case as well as prepare a presentation. Delegates will have the opportunity to use their knowledge of accounting concepts to solve real-world problems that influence the industry and connect with our theme, "Financial Crime." Upon the conclusion of this time, each team will present their solution to, and be evaluated by, a panel of expert judges.

PRESENTATION:

During the case cutting, teams must prepare a 20-minute presentation to be exhibited by our stellar panel of judges, followed by a 5-10 minute questioning period. Once the initial round is complete and judges have decided who will proceed to the next round, the top 4 teams will present in the finals in front of all teams and judges.

WORKSHOPS & SPEAKERS

Workshops

Workshops will be scheduled and hosted throughout the conference to help delegates strengthen their skills and knowledge in relation to our theme; Financial Crime. Expect to learn from industry professionals and leaders about the future of the accounting industry and how to succeed in a constantly changing world.

Networking

Networking sessions have been allotted over the course of the conference for delegates to engage in formal networking with industry professionals, sponsor representatives, alumni and other delegates. These sessions will be your opportunity to expand your network and establish valuable relationships.


ACCOMODATIONS
