# **Excerpt from Senate Bylaw 1**

# 8. Declarations of conflict of interest

8.01	At the beginning of each meeting of Senate or any of Senate's committees or councils, the chair will call for members to declare any conflicts of interest with regard to any agenda item. For agenda items to be discussed in closed session, the chair will call for declarations of conflict of interest at the beginning of the closed portion of the meeting. Members may nonetheless declare conflicts at any time during a meeting.	
8.02	A member shall be considered to have an actual, perceived or potential conflict of interest, when the opportunity exists for the member to use confidential information gained as a member of Senate, or any of Senate's committees or councils, for the personal profit or advantage of any person, or use the authority, knowledge or influence of the Senate, or a committee or council thereof, to further her/his personal, familial or corporate interests or the interests of an employee of the university with whom the member has a marital, familial or sexual relationship.	
8.03	Members who declare conflicts of interest shall not enter into debate nor vote upon the specified item upon which they have declared a conflict of interest. The chair will determine whether it is appropriate for said member to remove themselves from the meeting for the duration of debate on the specified item(s).	
8.04	Where Senate or a committee or council of Senate is of the opinion that a conflict of interest exists that has not been declared, the body may declare by a resolution carried by two-thirds of its members present at the meeting that a conflict of interest exists and a member thus found to be in conflict shall not enter into debate on the specified item upon which they have declared a conflict of interest. The chair will determine whether it is appropriate for said member to remove themselves from the meeting for the duration of debate on the specified item(s).

#### 1. DECLARATIONS OF CONFLICTS OF INTEREST

#### 2. APPROVAL OF THE 9 MAY 2023 MINUTES AND BUSINESS ARISING

The following revisions were requested: The title of item 2 be corrected to "Approval of the 11 April 2023 Minutes and Business Arising"; for Item 3, under Software Engineering, add "page 120" to the third sentence so it reads "Grove provided an overview of the minor academic plan changes for Software Engineering and Software Engineering Sequence Change, highlight a typo in the material: on page 112 and page 120 under Science Course Electives, it should be "four of", instead of "three of"."; and correction of the spelling of Anson Huang's name.
