### **Excerpt from Senate Bylaw 1**

### 8. Declarations of conflict of interest

- 8.01 At the beginning of each meeting of Senate or any of Senate's committees or councils, the chair will call for members to declare any conflicts of interest with regard to any agenda item. For agenda items to be discussed in closed session, the chair will call for declarations of conflict of interest at the beginning of the closed portion of the meeting. Members may nonetheless declare conflicts at any time during a meeting.
- 8.02 A member shall be considered to have an actual, perceived or potential conflict of interest, when the opportunity exists for the member to use confidential information gained as a member of Senate, or any of Senate's committees or councils, for the personal profit or advantage of any person, or use the authority, knowledge or influence of the Senate, or a committee or council thereof, to further her/his personal, familial or corporate interests or the interests of an employee of the university with whom the member has a marital, familial or sexual relationship.
- 8.03 Members who declare conflicts of interest shall not enter into debate nor vote upon the specified item upon which they have declared a conflict of interest. The chair will determine whether it is appropriate for said member to remove themselves from the meeting for the duration of debate on the specified item(s).
- 8.04 Where Senate or a committee or council of Senate is of the opinion that a conflict of interest exists that has not been declared, the body may declare by a resolution carried by two-thirds of its members present at the meeting that a conflict of interest exists and a member thus found to be in conflict shall not enter into debate on the specified item upon which they have declared a conflict of interest. The chair will determine whether it is appropriate for said member to remove themselves from the meeting for the duration of debate on the specified item(s).

### **5. BUSINESS ARISING FROM THE MINUTES**

### 8. CURRICULAR SUBMISSON - ARTS

Council heard a motion to recommend to Senate to approve the deletion of the Coursework study option for the Master of Arts (MA) in Economics, effective 1 May 2023, as presented. As part of that change, a new course in data science for economics (including techniques and coding specific to economics) is proposed. Esselment and Ferrer. Carried.

### 9. SENATE GOVERNANCE REVIEW MEMO

Council received for information the Senate Governance Review Memo as presented. Members are to anticipate invitations to stakeholder consultation sessions to be held in the winter term. Council proposed some new ideas in relation to the future of SGRC: (a) separate the existing council into research and graduate councils; open invitation for all existing SGRC members to attend each; voting privileges held by direct members of the respective new councils, (b) separate the existing council into research and graduate councils; convene as one body at some frequency (e.g., once or twice per year), and (c) continue as the existing council; cover common interest items early in the agenda so members can leave as appropriate.
