Course Description and Learning Outcomes

Course Description

SOCWK 222R is an examination of social work practice as it relates to functional and geographical communities. The course will explore the theoretical foundations of organization practice as well as a variety of models.

Learning Outcomes

By the end of this course, you will be able to:

- Examine social work practice as it relates to functional and geographic communities, particularly in the Canadian context.
- Explain the principles, basic assumptions, and theoretical foundations of community organization practice.
- Describe a variety of approaches to community organization, their particular application, and their related strategies and skills.
- Critically examine community organization practice in relation to the dynamics of power at the community level, toward the development of a critical approach to social work praxis.

About the Course Author

Robert Case is an Associate Professor in Social Development Studies, at Renison University College, whose teaching, research, and voluntary interests revolve around community organization in its many forms. He has a PhD in social work from Wilfrid Laurier University, an MSW from the University of British Columbia in Vancouver, and a BSW from McGill University in Montreal.

Over the course of his career, Rob has worked in child welfare, international development, community development, and community based research. Here at Renison, Rob teaches courses in the Social Policy and Social Action specialization, including courses on social policy (SOCWK300R Canadian Social Welfare Policy and SDS400R Comparative Social Policy), community organization (SOCWK222R Community Organization 1 and SDS322R Community Engagement and Social Development) and social ecology (SDS260R Ecology, Society, and Justice).

Rob is active is a community member, and is becoming increasingly interested — as a volunteer, a community organizer, and as a scholar — in trying to understand and articulate the interconnectedness of social justice with ecological sustainability. As a scholar, Rob has contributed work to an emerging body of literature in "environmental" or "eco" social work, and has published articles that draw lessons from grassroots environmental action for community engagement and social action in other domains. Based on experiences and relationships built in the course of research on community-based water activism, Rob is currently Chair of the board of a Guelph-based social movement organization called the Wellington Water Watchers. Rob is also involved as a researcher in documenting and identifying promising practices from an examination of community development initiatives in the community health sector.

As will become apparent, as you go through the course and are introduced to different examples of community organization, Rob lives in Guelph.
