OPEN SESSION

1. PRAYER & TERRITORIAL ACKNOWLEDGEMENT

M. Pautler provided an acknowledgement that St. Jerome's University and the University of Waterloo reside and operate on the traditional territory of the Attawandaron, Anishinaabeg, and Haudenosaunee peoples. The University is situated on the Haldimand Tract, the land Frederick Haldimand granted to the Haudenosaunee of the Six Nations of the Grand River in 1784 that includes 10 kilometers on both sides of the Grand River and extends from its source to Lake Erie.

The prayer was provided by M. Pautler.

2. CHAIR'S REMARKS

The Chair thanked K. Kaczala for her support and work with the Board and wished her well on her maternity leave.

A warm welcome was extended to the newly appointed Board Members: Ayo Owodunni, Shannon Straus, and Kat Møller.

The Chair also noted that Alan Rego recently submitted his resignation from the Board and expressed gratitude for A. Rego's contributions during the time he served on the Board.

3. PRESIDENT'S REMARKS

The President provided the Board with relevant updates and reminders, including:

- The Orientation and Investiture Ceremony was once again a success with more than 300 students in attendance this year.
- The Lectures in Catholic Experience 2024-25 season has begun with two lectures being held in September. The next LCE event will be held on November 14th with speaker Matt Hoven talking about Father David Bauer.
- Recently represented the Association of Catholic Colleges and Universities in Canada at the Fall Canadian Conference of Catholic Bishops (CCCB) Plenary Meeting.

- Have been holding meetings with the Catholic Education Partnership members within the Diocese of Hamilton to discuss the future of Catholic identity within schools within the Diocese.
- The Indigenous Advisory Circle will be holding its first meeting of 2024-25 next week and will be focusing on the creation of an Indigenous Strategic Plan for St. Jerome's.
- On October 21st the University will be welcoming former Supreme Court Justice Frank lacobucci to speak on Canada and Indigenous People working towards a better relationship.
- P. Meehan also wished K. Kaczala well on her maternity leave and announced that Grace Nandi has been hired to provide support to the President's Office and Board of Governors while K. Kaczala is on leave. G. Nandi will be starting her role on October 21st.

4. VICE PRESIDENT ACADEMIC AND DEAN'S REMARKS

The VPAD reported on relevant items from her area, including:

- Fall 2024 student enrollment data included with the Board materials notes the number of co-registered students who are taking classes at SJU.
- The Master of Catholic Thought program review is still in progress.
- The Certificate in Catholic Leadership program has now launched with 23 participants from institutions from across the Diocese of Hamilton.
- Following the recent review, the Sexuality, Marriage and Family Studies program has now undergone a name change to Sexuality, Relationships and Family Studies (SRF) to better reflect the courses the University teaches within the program.
- The new Dean of Arts has begun their role and has put together working groups to assist with the process of restructuring the Faculty of Arts.
- Ryan Touhey, faculty member within the Department of History was recently quoted by the BBC.
- Jane Nicholas, another faculty member within the Department of History, was recently appointed as co-chair of the Canadian Committee on Women's and Gender History.

S. Moule also remarked that Louis Hall is now fully occupied with graduate students which has resulted in an increase in ancillary revenues.
