Course Description

This course emphasizes the pre-production fundamentals of multimedia design on a project basis. Working in small groups, students produce treatments, storyboards, and production plans for a variety of short video and animation projects. Students learn a theoretical vocabulary to analyze, critique, evaluate, and communicate about their projects. Focusing on the social nature of storytelling with digital video and animation, the course serves as a hands-on digital media lab where students acquire skills in using a variety of software and digital equipment.

GBDA 201 places the bulk of your reading and research at the start of the course, with production and post-production being the focus in the second half. Students are expected to have readings completed for each week and come prepared to discuss, question, and comment on course materials.

Film-making is a collaborative art and requires commitment and follow-through on everyone's part in order to be successful.
