

The University of Waterloo has suspended all University-related international travel outside of Canada until further notice due to COVID-19. At this time, we will only consider President's International Experience Award claim requests for:

1. an eligible documented international experience **from a previous term** for which you have not yet submitted a claim form (undertaken during the 2A term or above and prior to COVID-19 travel suspensions)
2. a Winter 2021 or Spring 2021 work term undertaken outside of Canada which has been approved for co-op credit based on exceptional criteria – refer to [Co-operative Education](#) for full details

Eligibility criteria

- You must have received the President's Scholarship of Distinction in Year One.
- You must have completed Year One with a minimum cumulative average of 80%.
- You must be a continuing full-time undergraduate student registered with the University of Waterloo.
- You must have participated in an approved international experience (outside of Canada) including:
 - study abroad or exchange program
 - co-op work term
 - field placement undertaken to fulfill a degree or course requirement
 - volunteer term related to a Waterloo sanctioned service-learning program (e.g., Beyond Borders)
 - other documented international experiences may be considered
- The experience must have been of sufficient duration (normally minimum one month).
- Remote international work-term experiences undertaken in Canada will not be considered for this award.
