The Sustainable Development Solutions Network on an International Scale

Professor Jeffrey Sachs will discuss his motivations for creating SDSN in 2012, and how it cooperates with the United Nations Agencies and other global organizations. He will also share examples of projects that SDSN has spearheaded over the past six years and highlight success points and areas of opportunity for Canada to contribute towards. Maria Cortés Puch, Head of the SDSN Networks Program will be the second panelist, speaking to the role of partnerships and membership through SDSN and how other SDSN networks from throughout the world have been established and are governed.

The Sustainable Development Goals (SDGs) in Canada

A conversation on Canada's current state of progress towards the SDGs, identifying organizations and institutions working on the SDGs, commitments that have been made, and gap/opportunity areas for further work. A number of targets are associated with Sustainable Development Goal #4 – Quality Education. Many of these goals focus on improved access to free, equitable and quality education and the provision of other supports and services that achieve increased levels of literacy,

numeracy, knowledge and skills for all, focusing in particular on developing regions. As the world moves forward with the implementation of the Education 2030 Agenda, there is an opportunity for Canada to take a strong role.

This session will explore a number of SDGs, with an emphasis on SDG #7 – Affordable and Clean Energy and SDG #13 – Climate Action. The session will be framed around addressing three main questions and issues:

- 1. Post Paris Climate Change accord, are there any new developments or findings that undermine the scientific basis (or, is there new evidence for moving to the 1.5 C target with urgency)?
- 2. What is the nature of the energy transition challenge for an effective response to mitigating the threat of climate change and is the scope and scale of technological shift required for change achievable within reasonable parameters of global financial capacity?
- 3. Is the Canadian capacity for social, business and policy innovations robust enough and adequate to meet the aspirations of a low carbon energy economy?
